

# WESTERN BALKAN NETWORK ON TERRITORIAL GOVERNANCE

In order to define itself as a distinguished contributor vis-à-vis EU territorial governance policies and in line with the Western Balkan Enlargement Strategy, Co-PLAN proposed the establishment of a regional network. Western Balkan Network on Territorial Governance (TG-WeB) serves as a platform aimed at bringing forward the research on territorial governance in the Western Balkan countries bringing together research and policy-influencing forces from the region. In more specific terms, the network will work on undertaking pioneering research and policy advocacy across the region, to enhance the domestic territorial governance and impact in a 'unique voice' the EU integration of the Western Balkans from a TG perspective. In so doing, the network aims to strengthen the Western Balkans-EU partnerships at the level of academia, researchers' community, and civic society for dealing with territorial development in the region in a combined EU-domestic bottom-up fashion. The establishment of a regional network on Territorial Governance comes at a timely moment: all countries of the Western Balkans region -Albania, Montenegro, Serbia, Bosnia Herzegovina, Macedonia, and Kosovo - share, despite their diversity and idiosyncrasies, a common aspiration for a future within the EU. As a region, we share similarities with respect to our development and integration agendas, as we do face the imperfections of our planning systems and Territorial Governance practices.

# Initiating Workshop – May 17-19, 2018

Prospective partners, from the Western Balkans and EU member countries, gathered in Tirana for a network initiating workshop organized and hosted by Co-PLAN and POLIS University, on May 17-18. The network benefits from the voluntary membership of organizations and individuals from all Western Balkan countries, and organizations from the wider Balkans region and the EU.





### Position Paper on Territorial Governance for Western Balkans

The workshop participants shared knowledge and challenges on territorial development and governance in their countries and in relation to EU and developed published online and disseminated a joint 'Position Paper on Territorial Governance for Western Balkans'. TG-WeB set forth this position paper as the EU reconfirmed its enlargement vision for the region, making for a timely introduction of territorial governance in the enlargement agenda. The network adopted a macro-regional perspective in identifying and proposing a number of recommendations as to how territorial governance can play a role in the Western Balkans





# National Activism Day 2018

Co-PLAN organized for the first time in Albania, the National Activism Day #NAD, on the 22nd of October 2018. This evet was a culmination of a two-year effort to strengthen, help and mentor civil society organizations in their attempts to bring forward a cause or social problem in their community. NAD brought together more than 50 organizations of different backgrounds advocating for social justice, protection of human rights, social development, gender equality etc. The event incorporated different components within itself with a nationwide coverage. The day started with a ceremonial event where 5 inspirational individuals presented their initiative as some of the best examples of change. The aim was to demonstrate that through commitment and hard work both organizations and individuals can bring about the change we want to see in the society. These representatives of the civil society in Albania were chosen carefully after several consultations with the donor community and the American Embassy and also taking in consideration their work and the impact they might have in the society. Another component of NAD was the Activism Fair organized in the main square of the capital city Tirana, where over 35 organizations as well as newly established ones brought together groups of volunteers, partners and representatives of communities to showcase their efforts in their field of work. At the same time more than 15 local organizations organized activities with their communities in the framework of NAD.









Civil Society Organizers were invited to participate in an interactive workshop to share their activism experiences at the workshop following National Day of Activism. Participants had the opportunity to learn the best practices and be inspired by a highly experienced community activist and organizer in America, Dave Beckwith.



In the framework of NAD 2018, an open discussion was organized with members from the US Embassy Youth Council. Dave Beckwith gave an impressive presentation about the human rights movement in US and how communities need to organize for social change.

The GLTPs are conceptualized as comprehensive and integrated documents and blueprints, so that local authorities and citizens can better plan for social, economic, physical, political, aesthetic and any other issues that help municipalities to achieve their overall development goal. Co- PLAN has worked intensively with all five model municipalities to draft the GLTPs, with all their integral documents and approve them on local and central levels. ### Round-table on the Implementation of GLTPs

On the 15th of November a round-table on LDPs and Feasibility studies was organized in cooperation with the NTPA. Representatives from 61 municipalities (around 80 urban planners) took part in the event. The event was composed in two parts, initially presentation by PLGP experts on the experiences with our partner municipalities of Lushnje, Kuçove, Elbasan, Fier and Tirane and afterwards through a Q&A session on different issues that the municipalities raised regarding the process of preparing LDPs, applying FILDs and implementing GLTPs. The roundtable was received positively by the participants who actively took part in the discussion and served as a basis for sharing experiences and discussing common challenges.









# **Training of Municipal Staff**

Co-PLAN experts trained the representatives from the Municipalities of Fier, Lushnja, Kuçova, Berat, Tirana, Divjaka and Elbasan regarding the implementation of their General Local Plans. The workshop focused on two main issues such as the drafting of the Detailed Local Plan and the clarification and implementation of the General Local Plan. The discussion impacts directly the municipality work in the process of implementation of the GLP's.

# Decentralization and Local Regional Development

For many years Co-PLAN has supported local governments, NGOs, and business communities in addressing urban development issues through the preparation of territorial development strategies, urban regulatory plans, detailed local plans, and other guiding documents. The advancement of the decentralization process and the increasing number of responsibilities delegated to local government have made imperative clear policies on the financing and implementation of local economic development strategies. To this end, Co-PLAN supports and advises local governments to improve municipal finances management practices and adoption of new instruments in the pursuit of their development strategies. In recent years, Co-PLAN has supported many municipalities to improve financial performance through the preparation of the capital investment programs, annual budgets generated through participatory practices, and the improved levying of taxes.

# **Regional Development Programme**

Regional Development Programme Albania - Phase 3 – started on 1st April 2017 based on an approved bi-lateral agreement between the Government of Albania and Government of the Confederation of Switzerland, respectively represented by the Ministry of Urban Development (and further by the deputy Prime Minister office) and Swiss Development Cooperation (SDC) Tirana Office. The project is being implemented by ECORYS Netherland in partnership with Co-PLAN, Institute for Habitat Development.

The reform on regional development needs support on different levels to finalise the elaboration of a vision for regional development as well as to make its implementation successful. Capacities for implementing the reform were not in place and newly established institutions not yet functioning.

The first part of the programme tackled the national as well as the regional level. On the national level the support to the reform on regional development continued based on the results of the bridging phase (policy and legal framework), such as the development of bylaws (legal framework), the follow-up on the new financial framework (new modality of Regional Development Fund), support in (vertical and horizontal) coordination and other areas, following the demand by the central government.

In the second part the support primarily addressed the (former) newly created structures – mainly the National Agency for Regional Development and the four Regional Development Agencies; support was also directed to other institutions involved in RD, such as regional and local stakeholders. Support included strengthening the emerging institutional system of RD agencies (capacitydevelopment, institution-building, participative approaches) and

the elaboration of Policy and Programme for RD and Cohesion and Operational Programmes in a participatory way. The third part of the programme focused on the preparation of a grant fund mechanism, including criteria for project selection, piloting of regional development projects to establish and test the new grants mechanism anchored at the Regional Development Agencies (now ADF) by end of this project and implemented through the mechanism thereafter.

The core processes initiated and undertaken were:

- Setting up the legal framework and system •
- for *Regional Development;*

Programming process at regional and • national level mainly focusing on drafting and finalising the four Regional Development Programmes (RDPs) and Policy and Programme for Regional Development and Cohesion (PPRDC);

Capacity building for regional and local institutions (RDAs and Municipalities);


*Implementing the Regional Development* Pilot Grant Scheme through financing of 16 *municipal projects;* 

*Capacity building at regional and central* level on grant management, project selection and evaluation, monitoring and reporting in accordance with EU standards and requirements.



### Policy and Legal Framework for Regional Development in Albania

It was mainly anchored to the formulation, harmonization and amelioration of policy and legal framework of Regional Development in Albania. As such, good progress was made in providing a final set of relevant documents (technical papers, policy briefs, guidelines) concerning Regional Development policy, Policy and Programme for Regional Development and Cohesion (PPRDC), Vision and Principles of RD, Policy Implementation system and Institutional set- up system for RD.

In addition, 3 draft by-laws were prepared to ensure the proper implementation of the Law on Regional Development and Cohesion, specifically:

Draft bylaw on structure, methodology of making and ways of alignment of development programming documents for regional development;

Draft bylaw on founding, structure, organisation . and tasks of the National Regional Development Committee;

Draft bylaw on founding structure, organisation and tasks of the Regional Monitoring Boards.

The draft Law on Regional Development and Cohesion provides a good structure and covers almost every detail needed to establish an appropriate legal framework enabling the functioning of the Regional Development system.



# **Regional Pilot Grant Scheme and capacity building**

During the implementation of the programme, RDPA successfully concluded the preparation of the institutional mechanism and a set of documents needed for the set-up of the Regional Pilot Grant Scheme which was successfully implemented in compliance with EU criteria and standards. After a long process of consultations with the DDGG and the four former RDAs, the Regional Pilot Grant Scheme was approved by all parties and launched on 11th April 2018.



This pilot grant scheme was at first considered an indispensable exercise for the former RDAs as intermediate bodies, and for the Municipalities as final beneficiaries, as it established a new regional institutional trajectory and provided the basis for a better absorption of funds. Out of 47 applications which were delivered under the published call, 16 municipal projects were selected and financed by RDPA with a total amount of 817.000 euro. The awarded projects which aimed at improving the socio-economic conditions of the local communities by tackling small-scale local investments in education, tourism, sports, culture and community infrastructure, were equally distributed in the four regions of Albania.







The implementation of the Pilot Grant Scheme was closely accompanied by a series of trainings for the staff of the former RDAs, in order to further consolidate and institutionalize their role as intermediate bodies at regional level and strengthen their capacities in order to ensure sustainability in funds absorption. In the follow-up of the structural changes caused by DCM No.348 18/07/2019, the staff of all four RDAs was absorbed by Albanian Development Fund, therefore, the remaining trainings were prepared and adapted to the new institutional context having as target staff from the four Regional Development Units and ADF as the new Managing Authority.

The 16 development projects financed under the Pilot Regional Grant Scheme were successfully implemented and finalized by the beneficiaries, thus absorbing 92% of available funds.

The implementation of the Grant Scheme was accompanied by capacity building activities which aimed not only to strengthen capacities of RDAs and Municipalities' staff but also introduce changes in the system in regards to projects' evaluation, implementation and monitoring. To this regard, 203 people were trained under outcome 3. out of which 119 were women.



### Preparation of the Policy and Programme for Regional Development and Cohesion and Regional Development Plans; Capacity building of the institutions dealing with RD in Albania

The RDPA programme supported the strengthening of the institutional system of RD, the preparation of the PPRDC and the preparation of RDP in a participatory way ensuring a partnership approach by integrating local government into RD programming.

RDPA's regional experts in collaboration with the former RDAs significantly progressed the programming process at regional level, including also Municipalities from the four regions, which were highly interested in the programming exercise.







This process was duly accompanied by several trainings and workshops based on a Training Needs Assessment and training map designed ex-ante, in order to provide tailor-made capacity building activities for the beneficiaries of the Programme. During this phase, 229 persons participated in trainings and workshops, out of which 95 were women. At central level, significant progress was made in terms of discussing with the DDGG at the PMO's Office and with ADF for approving the structures and the timeline for the preparation/finalisation of the programming documents such

as Regional Development Programmes (RDP), Policy and Programme for Regional Development and Cohesion (PPRDC). All partners which were involved in the process, at regional and national level, understood the relevance of the process, the role of the documents and the ambitious timeframe in which the documents needed to be prepared in order to comply with the government's plans to advance with the Regional Development Policy implementation for the period 2020 – 2027.



# **Urban Partnership Program III**

The World Bank-Austria Urban Partnership Program III (UPP) is a regional program which aims to strengthen the capacity of local governments in South-East Europe (SEE), and to equip local elected officials, city administrators and technical staff with practical tools for decision-making to effectively manage urban development for inclusive and sustainable growth. The Program is targeted at the Western Balkans, including Albania, Bosnia and Herzegovina, Croatia, Kosovo, Macedonia, Montenegro and Serbia. During 2018, Co-PLAN was engaged in two of the components of the program:

### Urban Audit

The main focus was to address the main challenges faced during the implementation of the Urban Audit framework in the referenced municipalities (Fier, Lushnie, Berat, Elbasan and Kucovë in Albania and a few others in Macedonia). Upon finalization, it proved to be a successful tool for all participant municipalities because it fostered an efficient use of resources and a better link of planning objectives with the financial abilities. It served as an exercise of good governance, by creating a transparent process, with participatory project selection, and a general environment of trust for the proposed projects. Moreover, it helped raise the capacities of local governments in data collection and processing, by also providing an accurate database available to be used for further purposes.

### Municipal Finance Self-assessment

Municipal Finance Self - Assessment (MFSA) component aims at enabling municipalities to assess city's local public finances management, identify specific actions to improve mobilization of local resources, expenditure allocation and investment programing, local asset management and access to external financing. The MFSA tool was used in 10 municipalities: Elbasan, Berat, Lushnjë, Fier, Kuçovë, Vlorë, Himarë, Sarandë, Gjirokastër, Përmet

This project which started in 2014, is in the last year of its first phase and supported by the Swiss Agency for Development and Cooperation (SDC). Local concerns are addressed through mechanisms such as: Inclusive decision-making; Supervision of local government; Transperancy; Responsability; Accountability; Monitoring the guality of public services. During 2018 the 5th Call for Applications was launched, amounting to 36 winning projects, from which 9 ideas were presented by individuals and 27 were from Civil Sociaety Organisations.

In May 2018, Local Democracy Week was organised, bringing together expert organisations into a series of debates, forums, workshops and activities which highighted the main achievements of the projects supported by LA. During this week, Co-PLAN presented the Status Report of the Public Local Finances for the year 2017 which comprised an elaborate analyses of the performance, trends and the financial situation of 61 municipalities in Albania.



# The Municipal Financial Data Portal www.financatvendore.al

The online platform www.financatvendore.al was introduced to students at the University "Fan Noli", in Korca and University "Aleksandër Xhuvani", in Elbasan. Students were encouraged to make use of the platform as an innovative tool for research and different economic analysis.

The Status Report of the Public Local Finances was introduced also to representatives from the Qark of Korça. Co-PLAN expert on local finances elaborated on the financial situation and the data analysed with a special focus in the Municipality of Korça.

# Environmental Management and Planning

The Environmental Management and Planning Unit built on Co-PLAN's sensitivity towards the irreversible impact of rapid urban development on the environment. Constant contribution and works within the habitat development framework, conducted by Co-PLAN, have always taken under consideration crucial elements in regard to sustainable development of the ecosystem. We consider Environmental Management and Planning as a criss-cross dimension for each of the projects we commit and deliver. Upgrading services delivery standards and capacity building for a better comprehension of environment at an institutional level, were listed as first contributes from Co-PLAN on the field of environmental protection. During the last 15 years these themes expanded towards strategic environmental pacification, environmental impact assessment, ecosystem services evaluation, governing natural resources, energy, etc.

# **ENV.net Factoring the Environmental** Portfolio for WB and Turkey in the EU Policy











The network aims to generate region-representative evidencesupported input to contribute to EU discussions on matters of climate change and environment, and to explore and introduce to the region new inter-related aspects such as circular economy. In the process, the network foresees to also technically and financially support civil society organizations and media in each of the network partner countries, to better understand and work on these issues.

The project specifically works on the strengthening of the network as a leading pan-regional actor in the WB and Turkey in orienting and influencing environmental and circular economy policy discussions at an EU level. It will also support local CSOs and media in the process of improving their skills and work related to environmental issues.

The Western Balkan and Turkey region faces a number of challenges impeding progress, such as: limited local buy-in of the reforms, conflicting legislation, lack of a critical mass that can monitor developments and exert pressure on policy-makers, weak dialogue with institutions, poor understanding and coverage of climate change and environmental news, and very sparse resonance with current EU environment-related discussions such as circular economy aspects.

# **KINDLE Advocacy**

KINDLE Advocacy was implemented by Co-PLAN with the support of the US Embassy in Tirana. The project tackled the need for the young CSO's and newly emerging activists to articulate evidencebased responses in influencing policymaking in pressing issues related to city-making, democracy and environment. The project aimed to strengthen internal capacities of local CSO-s and young activists to monitor, analyze, and undertake concrete steps/actions through a dual/integral approach, providing the target groups with both, capacity development and advocating experience. A tailored capacity development program was envisioned in the form of structured workshops and coaching components, covering five core themes under the overarching multilevel governance, such as elections, communication for impact, urban activisms, environmental resources and a free topic. In the process the participants improved their knowledge of how to engage in policy processes (monitoring, analyzing, influencing), how to establish dialogue platforms with the local/regional/ and national authorities, how to raise particular pressing issues within the sector, and how to initiate lobbying and advocacy actions in view of influencing policy-making.

# **#SiCucateDibres**

Over a one year period, the cause conducted significant research on the causes and consequences of the phenomenon, identifying key values and traditions of the area, mainly focused on the women figure. A number of Focus Groups (with teachers, parents and students/pupils) were held in order to get the full perspective of the causes and conditioning factors. The focus groups were followed by a dedicated cultural event in the form of a fair, where they exhibited their work and products, showcasing their skills and local handmade products, as well as offering the opportunity to discuss with the young girls on a

closer level on their aspirations and their future plans, what they envisioned for themselves and potentially explore on what they considered skills they would like to develop/acquire. A final event in the form of an inspiring talk by a Dibraborn successful role model, the no.2 figure in the Armed Forces of Albania, General Manushaqe Shehu, who encouraged both parents and the girls to view and pursue education as the driving force leading to both personal and community development.

### **Revival of Local Museums**

As part of the activity plan jointly developed with the team, Kevin undertook a preliminary research, a survey and a proactive social media campaign to introduce and raise awareness on local museum issues. The social media profiles of the cause triggered interest among public authorities who have regularly followed them. Based on the findings of the research, Kevin drafted a policy brief with recommendations to the relevant institutions, which was later presented and discussed in a dedicated forum. The type of cooperation and initiatives need to be supported. survey done and the policy brief produced was presented and

discussed among some of the prominent figures and experts in the museum management sector. In an open panel representatives of the Ministry of Culture, academics, researchers, experts of the field and students discussed over the current situation of local museums and commented on the policy brief delivered to the relevant institution by Mr. Jasini. The event turned into a successful constructive discussion on what needs to be improved and what



Co-PLAN coordinates the Professional Fellows Program for Albania, financed by the U.S. Department of State, Bureau of Educational and Cultural Affairs, and is organized by the WSOS Community Action Commission, Inc. – Great Lakes Consortium for International Training and Development (GLC). This program is a two-way exchange involving 38 professionals from five selected European countries (Albania, Bulgaria, Hungary, Romania, and Slovakia) and 19 mentor organization from the United States who will effect positive change in their communities. The overall goal of the program is to provide a professional development opportunity for mid-level emerging leaders and build a global network of professionals able to work effectively in an interconnected environment. The fellowship program was opened to professionals who are actively involved in programs related to citizen participation and advocacy (NGO/civil society development), civic education organizations, citizen advocacy groups, community activists and/or community organizers who work with marginalized or rural communities.

### First issue of the 'Annual Review of Territorial Governance in Albania'

In view of current socio-political ambitions and regional dynamics in Albania as part of the Western Balkans, Co-PLAN, Institute for Habitat Development and POLIS University, introduce the first issue of the 'Annual Review of Territorial Governance in Albania'. This is a platform aimed at furthering the research on territorial governance on a domestic and regional level, bringing together research and policyinfluencing actors from the Western Balkan countries. This annual publication is dedicated to the territory, given its intrinsic relation to resources, development, and consequently governance. The articles focus mostly on territorial or place-sensitive governance in Albania, but provide analyses and insights on the connections between national territorial frameworks and policies, and those in the European Union and in the Western Balkans, to enhance the domestic territorial governance and impact in a 'unique voice' the EU integration of the Western Balkan countries. The articles, deal with a number of sectors and their interrelation to the territory, and the various multilevel, polycentric forms of governance. Each article is a policy brief that makes use of research, information, and analysis carried out by the authors, and provides policy recommendations mostly to domestic institutions, while also contributing to reducing the information gap on Albania at an international scale.


