- project reporting;
- knowledge and expertise on one or more Green Agenda pillars;
- designing methodologies and approaches to assist in environmental conservation, sustainable use of land and resources, and advising policymakers on environmental best practices;
- carrying out site monitoring practices (air, noise, ecosystem services) to determine environmental impacts;
- collecting and analyzing environmental data;
- providing capacity-building activities for different stakeholders;
- identifying and contributing to critical research and acquisition areas such as renewable energy, climate change, etc.

## **Qualifications and Skills:**

- Experience in managing and leading at least two (2) projects;
- At least 7 years of proven professional experience on environmental issues;
- Master's degree in environmental engineering; environmental management; environmental and earth sciences, or any relevant field of the environment;
- Sharp analytical skills and ability to process and analyze data/information in both English and Albanian;

- Excellent knowledge and understanding of the environmental civil society organizations in Albania
- Familiarity with design/management/evaluation of different modalities of support to civil society (e.g. grant program, capacity development, direct support to networks, facilitation of policy dialogue) would be an advantage;
- Excellent command of the English language and fluency in both written and spoken English;
- Good organization and facilitation skills for conferences, meetings, workshops, networking, etc.;
- Excellent working competences on Office package (Word, Excel, PowerPoint)
