



Building on the foundations laid during its first phase (2020–2023), GreenAL II (2024–2027) seeks to institutionalize civic engagement in environmental policy-making, ensure local ownership of climate and environmental reforms, and foster sustainable, inclusive, and

accountable green transition pathways and meaninaful participation. GreenAL remains committed to ensuring that the environmental transition is not only effective, but also just, inclusive, and citizen-driven. Key Achievements



Towards Regional Circular Supply Chains

Knowledge exchange from V4 to WB

The project seeks to support the advancement of circular economy practices in the Western Balkans (WB) by drawing on the experience of the Visegrad Group (V4), a regional cooperation platform between Poland, Czechia, Slovakia, and Hungary. Designed as a launching point for crossregional knowledge exchange, the project explores practical ways to assist stakeholders, policy makers, SMEs, and civil society, in strengthening circular transition pathways in WB countries.

Key Achievements

Dedicated Workshop in North Macedonia

As part of the conference "The Undeclared: Political, Economic and Sustainable Future of the Western Balkans," a workshop titled "Is a Regional Circular Supply Chain Possible?" provided a platform to present and debate key findings from the project's research. Discussions focused on the state of waste management regulation in the WB, with particular attention to Bosnia and Herzegovina and North Macedonia. Participants pointed to fragmented regulatory frameworks, weak enforcement mechanisms, and low levels of public awareness as major challenges to advancing circular practices in the region. This initiative marks an important step toward fostering collaboration, sharing expertise, and building the foundations for a more circular and sustainable economic model in Southeast Europe.



Preparation of Local Disaster Risk Reduction Strategies and Action Plans for the 6 Municipalities of Fieri Region

This assignment, part of UNDP's RESEAL Project (Resilience Strenathenina in Albania), builds on preparatory work initiated in late 2023 and was implemented throughout the first half of 2024. The objective was to equip the six municipalities of Fier Region (Fier, Lushnje, Roskovec, Divjakë, Patos, Mallakastër) with tailored Disaster Risk Reduction (DRR) Strategies and Action Plans, aligned with Albania's national DRR policy and Law 45/2019 on Civil Protection. Through this joint effort, Co-PLAN and Metro_POLIS supported municipalities in institutionalizing risk-informed planning preparedness, emergency following a previous vulnerability assessment and preliminary

Strategy drafting included SWOT analyses, problem tree exercises, and the design of three strategic obiectives per municipality focused on institutional capacity, community preparedness, and taraeted risk-reduction interventions. Each municipality now has a complete DRR strategy accompanied by an action plan with costed, prioritized measures (structural and non-structural). implementation timeline, and a monitoring framework. A consolidated coordination meeting with all mayors, UNDP, and NCPA in Roskovec finalized the strategies, which were then shared with local councils for approval. The process also contributed to capacity building, awareness raising, and the creation of a national model guideline for replication across Albania.

In 2023, Co-PLAN joined the Smart WB Erasmus+ Capacity Buildina in Higher Education project, coordinated by the University of Montenegro and implemented in partnership with 17 academic and non-academic institutions from the Western Balkans and the EU. The project, set to conclude in 2026, aims to enhance the quality and relevance of higher education in the field of climatesmart urban development (CSUD), with a strong focus on labor market alignment, interdisciplinary learning, and collaborative innovation. Throughout 2024, Co-PLAN continued to play a key role as a non-academic partner, supporting the modernization of university curricula and the integration of societal needs into academic production. Specifically, Co-PLAN contributed to the codesign of learning modules and facilitated dialogue between universities, civil society, and industry actors. This included identifying capacity gaps, promoting low-

carbon technologies, and initiating community engagement on emission reduction and sustainable urban transition.

In addition, the Smart WB project launched its technological platform to support CSUD education and collaboration across Western Balkan HEIs. Managed by the European University of Tirana (UET), the platform, accessible via Home | SmartWB E-Learning, offers tools such as e-learning modules, job listings, and discussion forums. It aims to enhance cooperation, knowledge exchange, and the modernization of university courses in line with EU standards. Designed to engage project partners, students, public institutions, and business stakeholders, the platform promotes inclusive access, content sharing, and capacity building, contributing directly to Smart WB's goals of improving teaching competencies, alianina education with labor market needs, and fostering regional collaboration.

In 2024, the EU4 Municipalities (EU4M) project, financed by the European Union, continued to unlock the potential of Albanian municipalities as drivers of sustainable development and better living conditions. By addressing gaps in infrastructure, governance, and service delivery, EU4M worked to bridge the urbanrural divide and ensure that local communities were better equipped to meet the challenges of today and tomorrow.

The project strengthened the ability of local governments to plan, fund, and deliver quality public services. It addressed persistent constraints in financial, administrative, and management capacity, enabling municipalities to provide reliable infrastructure, expand basic services, and create opportunities for economic development. In doing so, it fostered territorial cohesion and aligned local progress with Albania's broader path toward EU integration.

EU4M operated through a combination of direct grants, technical assistance, and community empowerment. Municipalities were supported to

design and implement strategic projects that responded to local priorities while ensuring citizen participation in defining and shaping development objectives. This participatory approach improved transparency and accountability and established a model of best practice for how governance could be inclusive, efficient, and impactful.

Through infrastructure upgrades, modernization of services, and reinforced local capacities. EU4M enhanced the daily lives of citizens, from improved public spaces and utilities to stronger conditions for entrepreneurship and social cohesion. The project also equipped municipalities with the skills and systems necessary to absorb EU funding more effectively, that ensurina investments translated into long-term benefits. The EU4Municipalities during the phase 2021–2024 was implemented by a consortium comprising the Network of Associations of Local Authorities of South East Europe (NALAS), Co-PLAN Institute for Habitat Development, Eco Partners for Sustainable Development, and the Albanian Association of Local Autonomy (AALA), with the support of the European Union.

Highlights

From organizing one or multi-day events on different issues, to participating in high-level international forums, Co-PLAN maintains a dynamic and engaging agenda throughout the year. Following are only some of the key highlights from the organization's activities over the past year.

Regional Leadership 2024 Award

For almost twenty years, the Co-PLAN Institute for Habitat Development has been awarding the "Leadership Award" to promote values and good examples in society in Government, Media, Civil Society, and Business. In 2024, Co-PLAN, in partnership with POLIS University, presented the **Regional Leadership Award to Mr. Dritan Abazović,** former first Albanian Prime Minister of Montenegro, in recognition of his commitment to democracy, regional cooperation, and European integration.

A political scientist and author, Mr. Abazović has played a key role in promoting institutional resilience, cross-border development, and coexistence in the Western Balkans. He is also a strong supporter of Co-PLAN and POLIS initiatives, as well as a promoter of the Buna River Bridge Project, as an effort with tremendous potential to strengthen tourism and development in Albania, Montenegro and the region.

The award ceremony was held at POLIS University, with participation from prominent figures, Co-PLAN and POLIS staff, and students.





TG-WeB

7th Annual Workshop in Sofia

The Western Balkan Network on Territorial Governance is established as a regional platform to advance research and policy dialogue on territorial governance, uniting academic and policy actors from across the Western Balkans

Hosted by Sofia University, the 7th Annual Workshop of TG-WeB – the Western Balkans Network on Territorial Governance convened partners from Albania, Serbia, North Macedonia, Montenegro, Greece, and Bulgaria to address green transition and SDG integration in national and local development policies.

The event explored the region's slow progress toward Agenda 2030 and emphasized the need for sustainability-driven governance models. Presentations and discussions focused on stakeholder perspectives, spatial planning scenarios, and case research from Montenegro.

Members engaged in strategic dialogue on the future of the network, including funding, membership expansion, and continuity of the TG-WeB Annual Review.

Advancing Local Resilience in Fier Drafting Disaster Risk Reduction Strategies

In 2024, Co-PLAN, in collaboration with MetroPOLIS, launched a series of working meetings across six municipalities in Fier District, Fier, Lushnje, Divjakë, Patos, Roskovec, and Mallakastër, as part of the project "Preparation of Local Disaster Risk Reduction Strategies and Action Plans for the 6 Municipalities of Fieri Region."

The meetings aimed to guide future activities and investments for disaster risk reduction through a comprehensive, inter-institutional approach. Experts from Co-PLAN worked closely with cross-

sectoral municipal teams to assess vulnerabilities, outline strategic objectives, and introduce initial project ideas.

These sessions marked the first phase in the strategy development process, with broader engagement planned to include local stakeholders and communities.

The project was implemented within UNDP's RESEAL initiative – "Strengthening Regenerative Skills in Albania," and is supported by the National Civil Defense Agency, with funding from the Governments of Sweden and Portugal.



Defending Albania's Protected AreasCivil Society in Action

In early 2024, Co-PLAN joined a broad coalition of civil society organizations, environmental experts, and academics in expressing strong opposition to proposed amendments to Law 81/2017 on Protected Areas, introduced by members of Parliament and reinforced by the Council of Ministers through a draft DCM dated February 7, 2024. The coalition criticized the proposals for undermining environmental protections by legalizing construction and strategic investments within protected areas, centralizing decision-making authority in the National Council of the Territory, and bypassing the role of local governments, the Ministry of Environment, and public consultation processes.

The amendments also threaten to allow infrastructure projects and uncontrolled interventions in ecologically sensitive zones, contradicting both national legislation and EU environmental directives. Of particular concern were proposed changes that enable interventions in water bodies and cultural heritage areas without clear safeguards. Civilsocietyrepresentativesurged Parliament and the government to withdraw the proposed changes, ensure transparency, uphold public participation, and align the legal framework with international standards for environmental protection and biodiversity conservation.





GreenAL

9 Roundtables to Engage Stakeholders

Between April and June 2024, GreenAL partners organized nine roundtables across Albania, eight at the regional level in key cities including Vlorë, Durrës, Elbasan, Shkodër, Fier, Pogradec, Dibër, and Kukës, and a final national roundtable in Tirana. These events served as a platform to present the GreenAL project's objectives, funding opportunities, timeline, thematic focus, and tools for environmental monitoring. With a strong focus on climate change, nature, and pollution, the discussions emphasized key issues such as urban waste management, biodiversity protection, habitat restoration, and air, water, soil, and acoustic pollution monitoring.

The roundtables brought together a diverse group of

over 230 participants, including representatives from 95+ organizations, 15+ municipalities and institutions, and 5+ educational institutions, with 60% female participation. These sessions offered valuable insight into the challenges and contributions of environmental CSOs and highlighted the importance of inclusive, multi-level dialogue in advancing the Green Agenda for the Western Balkans.

These roundtables served as a key instrument to validate and refine GreenAL's strategic direction for the years ahead. The insights gathered directly informed the development of the Programme Chart, the design of the grants scheme, the structure of the incubation program, and the institutionalization of the GreenAL network.









Roundtable on the Draft Law for Integrated Waste Management

As part of the GreenAL project, a roundtable was held on September 13, 2024, bringing together civil society organizations, businesses, and media representatives to discuss the draft law "On Integrated Waste Management." The discussion emphasized the need for broad public consultation and inclusive stakeholder engagement, recognition of local government capacities for effective implementation, clear

measures for waste prevention, recovery, and monitoring, as well as a standardized national methodology for waste data collection and reporting. A joint statement reflecting the main concerns and recommendations was submitted to the relevant institutions, underlining the importance of a transparent, inclusive, and accountable approach to the law's finalization and implementation.













Roundtable on the Draft Law "On the Energy Performance of Buildings"

On November 26, 2024, Co-PLAN, within the GreenAL project, organized a roundtable discussion on the draft law "On the Energy Performance of Buildings". The event gathered representatives from environmental CSOs and key stakeholders to reflect on the law's implications for the construction sector and its alignment with the Green Agenda for the Western Balkans.

Participants emphasized that the new law marks a significant step toward Albania's green transition goals. Key discussion points included the need to assess the applicability of the existing Law No. 116/2016, enhance institutional coordination for building decarbonization by 2050, and ensure equitable access to financing mechanisms, especially for vulnerable communities.

A Joint Declaration with detailed comments and recommendations was submitted to the responsible institution as part of the public consultation process, reinforcing the importance of inclusive dialogue in shaping a sustainable legal framework.









GreenFORCE

2nd RAB Meeting and 2nd Summer School in Belgrade

In mid May 2024, the GreenFORCE consortium convened its 2nd Research Advisory Board (RAB) Meeting and hosted the Second International Summer School in Belgrade. During the meeting, the partners of the GreenFORCE consortium showcased significant progress in their ongoing research cases. These cases focus on assessina JGT (Just Green Transitions) in Albania, Bosnia and Herzegovina, North Macedonia, Montenegro, and Serbia. The presentations hiahliahted advancements in understanding efficacy, environmental impact, and practical applications of JGT in these regions. The recommendations and suggestions provided by the RAB members are instrumental in refining the research methodologies and approaches. The experts offered critical feedback to enhance the quality and robustness of the research activities.

In parallel, The University of Belgrade hosted the in-person portion of the Second International Summer School of the GreenFORCE project, focusing on "Communicating Just Green Transitions - Navigating the Path to a Sustainable Future." Held from May 13 - 17, 2024 in Belgrade, Serbia, this event brought together students and experts to explore the vital role of communication in advancing sustainable practices. The summer school program was meticulously designed to convey the significance of sustainability through effective communication strategies. Bv integrating interdisciplinary approaches, technology, hands-on exploration, collaboration, and advocacy, the event aimed to empower students to become ambassadors of a sustainable future.



EFFORT

Bridging Borders, Empowering Communities in Albania and Kosova

As part of the EFFORT Project, Co-PLAN has worked alongside the Municipalities of Mirditë (Albania) and Junik (Kosova) to strengthen cross-border cooperation in the field of renewable energy and energy efficiency. In the first half of 2024, a series of meetings were held with key institutions, including ZRRE, KESCO, OSHEE, FKEE, the Energy Efficiency Agency, the Regional Environmental Directorate, and the local vocational school in Mirditë. laying the groundwork for more inclusive and sustainable energy strategies.

The project has fostered multilevel engagement, connecting local and national authorities, the private sector, and academia, to advance knowledge sharing, enhance energy infrastructure, and support long-term partnerships. This collaborative effort contributes to clean energy development, economic growth, and environmental protection in both countries.

The EFFORT Project is funded by the European Union through the IPA Cross-Border Cooperation Programme Albania–Kosova and implemented by Co-PLAN and partner municipalities.




Part Of Tirana Architecture Week Roundtable on Net-Zero Transition in Post-Communist Urban Neighborhoods

In October 2024, as part of Tirana Architecture Week, Co-PLAN and the GreenFORCE project organized a roundtable titled "Challenges in Achieving Net-Zero Transition in Post-Communist Urban Neighborhoods." The event brought together experts and stakeholders to address energy efficiency and sustainability challenges in aging urban housing stock across the Western Balkans.

The session featured the presentation of a national study on net-zero transition in Albania, followed by a dynamic panel which included discussion representatives from Tirana Municipality, ProCredit Bank, Albania, Milieukontakt and academia. The panelists discussed energy poverty, financing models, outdated infrastructure, and the role of civil society in green transition efforts. The event reaffirmed GreenFORCE's commitment to research, innovation, and policy dialogue in support of the Western Balkans Green Agenda, with a focus on the transition to netzero-emission buildings in postcommunist urban contexts.







Co-PLAN at the 36th AESOP Congress

From July 8–12, Co-PLAN participated in the 36th AESOP Congress in Paris, hosted by Sciences Po, gathering over 1,200 experts in urban studies under the theme "GAME CHANGER? Planning for Just and Sustainable Urban Regions."

Co-PLAN Executive Director Anila Bejko, project manager Fiona Imami, and Head of Territorial Governance and Spatial Planning Unit, Kejt Dhrami contributed to two thematic sessions. The first explored the conceptual foundations of a Just Green Transition for the Western Balkans, drawing from GreenFORCE project research. The second focused on Citizen Science in Spatial Planning, highlighting

democratic engagement practices developed through WBC-RRI.net and GreenLungs.

Co-PLAN also co-hosted a roundtable with Politecnico di Torino and Nordregio, featuring a high-level discussion on "Just Green Transitions: Transforming or Transitioning to What?", with panelists from POLIMI, Aalto University, and POLIS University. The Congress concluded on a celebratory note, as POLIS University, Co-PLAN's affiliated academic partner, was honored with the AESOP Quality Recognition Award. We look forward to continuing our international engagement at next year's congress in Istanbul.



Academia and SMEs Driving the Circular Economy / Info Day

On September 27, 2024, Co-PLAN hosted an INFO Day as part of the CROSS-REIS project, funded by the EU under the Horizon Europe Excellence Initiative. The project brings together institutions from eight countries and focuses on circular economy, waste management, and urban biodiversity, aiming to foster research excellence for a regenerative economy.

The event featured a roundtable discussion titled "Bridging the Gap: Challenges and Opportunities in Advancing Circular Economy for SMEs and Academia in Albania." Participants from academia, government, and the private sector

addressed barriers such as limited resources, regulatory constraints, and knowledge gaps. The discussion emphasized the need for stronger collaboration between SMEs and academic institutions to accelerate innovation and support Albania's transition to a circular economy.

Panelists included representatives from NASRI, Polis University, EU4Innovation, the Agriculture University of Tirana, and the EU4 Circular Economy and Livable Cities program. The session concluded with a forward-looking presentation of CROSS-REIS activities, reinforcing the project's commitment to expanding its impact across Europe.


















UNECE 2024 Regional Forum Side Event

Halfway to the SDGs in the Balkans

March 2024 - Sofia University, Department of Regional & Political Geography, Co-PLAN, Institute for Habitat Development, and POLIS University, Observatory of the Mediterranean Basin, as part of the TG-WEB network, organized a side event focused on the progress and challenges of implementing the Sustainable Development Goals (SDGs) in the Western Balkans.

Bringing together academic experts and network partners (TG-Web, SDGs Taskforce, RCN), the event highlighted modest regional progress toward Agenda 2030, while identifying key obstacles such as limited resources, political instability, fragmented governance, and lack of data systems.

The discussion emphasized the importance of local action, regional cooperation, and stakeholder partnerships to accelerate SDG implementation across the region.



GreenFORCE at the European Week of Regions and Cities 2024 - Brussels

From October 7–10, the 22nd edition of the European Week of Regions and Cities gathered thousands of participants from across the EU. As part of the event, Co-PLAN, in the framework of the GreenFORCE Horizon Europe project, co-hosted a panel discussion on October 8 in collaboration with the Covenant of Mayors for Climate and Energy.

The panel, titled "Multilevel Governance: Empowering Stakeholders in the Climate and Energy Transition", featured key insights from Miljenko Sedlar (REGEA, Croatia), Benedetta Brighenti (AESS, Italy), and Co-PLAN

Executive Director, Dr. Anila Bejko, moderated by Eero Ailio from DG ENER. Discussions showcased multilevel energy dialogues in Croatia, regional sustainability efforts in Italy, and the GreenFORCE approach to enabling inclusive, stakeholder-driven governance in the Western Balkans.

Inheraddress, Ms. Bejko emphasized the urgency of collaboration to navigate the green and digital transitions in the Western Balkans, highlighting Green FORCE's mission to build ownership, foster research excellence, and drive a just green transition in the region.





Webinar on Citizen Science

The WBC-RRI.NET webinar on "Spreading Citizen Science in the Western Balkans," held on 17 January 2024, convened regional experts, practitioners, and institutions to exchange practices and strategies for advancing citizen science as a meaningful tool for societal engagement, research, and policy development. The event spotlighted both opportunities and challenges in applying citizen science approaches across diverse thematic areas in the Western Balkans.

Opening remarks set the tone by outlining the potential of citizen science to democratize scientific processes, build trust, and generate actionable data for local and national decision-making.

A regional overview presented by Jana Panova mapped out existing initiatives across the Western Balkans, highlighting Serbia's leadership in the field and growing interest in environmental monitoring, biodiversity, and air quality across Albania, North Macedonia, Bosnia and Herzegovina, and Montenegro. Despite this progress, gaps remain in visibility, institutional uptake, and integration into education systems.

A standout contribution came from our researcher, Kejt Dhrami, who shared grounded reflections on the application of citizen science in Albania, emphasizing its value for both community empowerment and data triangulation in contexts of information scarcity. She detailed how continuous engagement with communities over an extended period allowed for the collection, validation, and interpretation of ecosystem service data.

The event closed with a call to action encouraging actors across the region to seize available funding opportunities (such as the IMPETUS call), strengthen institutional support mechanisms, and further embed citizen science in national research and innovation systems.

CROSS-REIS

3 Study Visits and 2 Capacity-Building Missions Advancing Regional and European Collaboration

As part of its commitment to fostering excellence in regenerative economy research, CROSS-REIS organized three targeted 3-day study visits in partner countries, Croatia, Montenegro, and Serbia. These visits enabled direct engagement with research facilities such as the University of Podgorica and University of Niš, and offered participants insights into regional innovation strategies, institutional capacities, and ongoing scientific efforts in the fields of urban biodiversity, circular economy, and sustainability transitions.

Beyond the Western Balkans, two strategic 5-day capacity-building visits were held in Spain and Norway. Hosted respectively by EMEA in Barcelona and OsloMet in Oslo, these visits focused on advancing participants' knowledge in regenerative economy stewardship, science-policy interfaces, and digital skills for research excellence. They also fostered peer learning

on governance models and institutional transformation toward areener, more inclusive innovation systems. Both the study and capacity-building visits served as platforms for exchange between academic, public, and civil society institutions. Participants explored synergies for future collaboration, shared experiences in project implementation and stakeholder engagement, and built crossborder networks that contribute to strengthening the Western Balkans' role in European research initiatives.

These mobility activities were not isolated events but part of a broader strategy to equip partner institutions with the tools, partnerships, and know-how to lead in regenerative innovation. They laid the groundwork for lasting cooperation, knowledge transfer, and the institutionalization of regenerative economy principles across national and regional agendas.











CCL

Demo Day: Showcasing Innovation for a Circular Future

The CCL Accelerator culminated in a dynamic Demo Day, which brought together entrepreneurs, experts, and partners to showcase the results of months of training, mentorship. coachina, and Eight businesses, including four women-led ventures, pitched their innovative solutions addressing reusable packaging systems and circular economy challenges. The event provided a platform not only for presenting business ideas but also for engaging in dialogue with stakeholders, jury members, and potential collaborators, underscoring the importance of sustainability-driven entrepreneurship in Albania.

The pitches were evaluated on feasibility, scalability, innovation, and alignment with circular economy goals. After careful assessment, six standout proposals were selected for pilot implementation: Barefoot Festival Eco Festival & TOK Digital Agency, Biocosm Laboratory, Birraria e Gjyshit, Gjelbër, Panja, and SilkyWet. These businesses are

pioneering solutions ranging from refill stations and reusable cup systems for events to returnable bottle models and borrow-and-return packaging schemes. Their projects reflect both the creativity of Albanian entrepreneurs and the program's commitment to building a greener, more sustainable local economy.

Beyond the competition, Demo Day highlighted the power of collaboration and knowledge exchange. International and local jury members provided constructive feedback, while the event created visibility for participating businesses through media coverage and stakeholder engagement. The celebration of innovation and the awarding of pilot projects marked a milestone for CCL-Tirana, setting the stage for the next phase: turning ideas into tangible, scalable solutions that will help drive Albania's transition toward a circular and sustainable future.

















Smart WB Workshop in Höxter Enhancing Digital and Experiential Learning for Climate-Smart Development

From March 19 to 21, 2024, Co-PLAN participated in the Smart WB Erasmus+ project's Theme-Based Training Workshop in Höxter, Germany, hosted by the OWL University of Applied Sciences and Arts. Organized under Work Package 3, Task 3.3, the workshop aimed to strengthen the capacity of Western Balkan Higher Education Institutions (HEIs) through practical, interdisciplinary training on innovative tools, digital platforms, urban transformation processes in the field of climatesmart urban development (CSUD). Co-PLAN was represented by urban planner Imeldi Sokoli, who joined partner institutions in a multi-day program combining technical learning, creative methods, and real-world site visits. The workshop began with an introduction to the OWL Sustainable Campus and lab tours that showcased applied environmental technologies and digital learning tools, including virtual tours and CO₂ balancing as sustainability metrics.

A highlight of the training was the "Lego Serious Play" methodology, which fostered creative, teambased learning on CSUD themes. Participants used LEGO to visualize challenges and co-design solutions in a highly interactive format that encouraged reflection, communication, and collaborative problem-solving—techniques increasingly relevant to student-centered university teaching.

Another major focus was digital pedagogy, with sessions on online learning platforms covering instructional design, learning theories, and group work to develop prototype online courses—skills participants like Sokoli will integrate into curricula design back home.

The program concluded with a field excursion to Essen, where participants explored the transformation of former industrial areas into climate-friendly urban spaces. Guided by local urban development experts, the visit included site tours and discussions with municipal actors







Co-PLAN at the Community of Practice on Affordable Housing Meeting in Ljubljana

Co-PLAN Strengthens Regional Cooperation on Affordable Housing through the Community of Practice in the Western Balkans

On May 22-23, 2024, Co-PLAN took part in the second in-person meeting of the Community of Practice (CoP) on Affordable Housing in the Western Balkans, hosted in Ljubljana, Slovenia, and supported by Habitat for Humanity International. event brought together 19 civil society organizations from across the region, fostering a shared commitment to advancina inclusive and affordable housing solutions.

The meeting focused on shaping two joint initiatives: (1) the renovation of multi-apartment buildings and repurposing of vacant spaces with an energy efficiency lens; and (2) improving housing access for Roma communities and other vulnerable groups through rights-based approaches. Hosted by Kralji Ulice, a leading Slovenian NGO

on homelessness and housing, the event offered a collaborative space for exchanging strategies and codesigning regional proposals.

Co-PLAN contributed insights drawn from its work on housing policy, urban informality, and spatial justice in Albania, with particular emphasis on energy poverty and marginalized communities. The agenda included facilitated sessions, a field visit showcasing Ljubljana's housing initiatives, and peer exchange on national policy shifts, publications, and upcoming funding opportunities.

The two-day event marked a pivotal moment for joint regional action, solidifying trust among network members and aligning efforts for the 2024–2025 period. Co-PLAN reaffirmed its active role in the network, committed to strengthening housing systems that are inclusive, climate-resilient, and grounded in social justice across the Western Balkans.







Transparency & Accountability

Transparency and accountability are key values at the heart of Co-PLAN's organizational culture and long-term success. These principles underpin our operations, decision-making processes, and relationships with partners, donors, and the communities we serve.

Co-PLAN's financial management is grounded in robust systems that ensure transparency, integrity, and compliance with international standards. Each year, the organization undergoes a full external audit conducted by an internationally accredited auditing firm. These annual audits provide an objective assessment of our financial health and governance practices.

To reinforce our commitment to openness, audited financial reports are made available to all interested parties upon request. This commitment to accountability reflects Co-PLAN's role not just as a project implementer, but as a trusted and responsible institutional actor in Albania and beyond.



Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the National Accounting Standards on Non-Profit. Organizations, and for such internal control as management determines is recessary to enable the preparation of financial statements that are free from material registerment, whether due to fauld or error.

In propering the financial abdomenta, management is responsible for assessing the Organization's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Organization or to cesses operations, or has no testitatic alternative that to do so.

Those charged with governance are responsible for overseeing the Organization's financial recording process.

Auditor's Responsibilities for the Audit of the Financial Statements


